# Proposed Consultative Visit to LLDA with regard to the "ILBM-Governance Project" and Field Visits to Basin Management Project Sites

#### **BACKGROUND**

Ministry of Education, Culture, Sports, Science and Technology, Japan, has granted Shiga University, Japan, a project fund to promote research on global collaboration on lake basin governance, specifically in regard to development and sharing of the knowledgebase on Integrated Lake Basin Management (ILBM¹). The project entitled "ILBM-Governance Project" in short² is jointly organized by International Lake Environment Committee (ILEC) and the University of Shiga Prefecture, Japan. The organizational structure and responsibilities of the project is shown in Attachment 1. Earlier, the Project has invited Ms. Lennie C. Santos-Borja, Chief, Research and Development, to serve as an international core member, and Mr. Niel Varcas, GIS Specialist, to participate in an Expert Group Meeting of Remote Sensing and GIS for Integrated Lake Basin Management held in July 2008. The "ILBM-Governance Project" wishes to dispatch a consultative mission to LLDA in October 2008, headed by myself, project leader and Director of the Center for Sustainability and Environment, Shiga University, and Chairman, ILEC Scientific Committee.

#### **OBJECTIVES**

The purpose of his visit is;

- to consult with relevant officials of LLDA with regard to inclusion of LLDA as a possible project site as well as other lake basins that may be contributory to as well as benefit from the ILBM-Governance Project, and
- 2. to explore the issues and agenda relating to the role and the initiatives of the young generation in pursuing the long-term objective as improvement of lake basin governance, specifically related to such emerging issues as adaptation to climate change in lake basin management. In this connection, a group of students and research scientists from the two Japanese universities will join my mission to learn from as well as to exchange with the community participation projects undertaken by LLDA.

As for 1. I would like to discuss the overall project formulation and possible approach for collaboration, keeping in mind that the project has significant bearings in promoting ILBM, a key

As for 2, the team, including myself, would like to be briefed on as well as to make visit to the LISCOP and Carbonshed Project sites to get a first-hand understanding of the significance of the projects. The team also would like to have opportunities to exchange with the community members that contribute to the implementation of these projects. They are particularly interested in the ongoing as well as perceived roles of the young generation in addressing adaptation in climate change impacts in general, with special considerations in lake basin management.<sup>3</sup>


